Car Nation Canada (the "Dealer") guarantees the original purchaser (the "Purchaser") of the vehicle (the "Vehicle") upon which the Car Nation Canada Anti Theft Marking System has been permanently installed that the Vehicle will not be stolen and that, in the unlikely event that the Vehicle is stolen, that the Anti-Theft Marking System will be effective in causing the return of the Vehicle to the Purchaser. Should the Car Nation Canada Anti-Theft Marking System fail to meet both of those guarantees, then 1) If the Vehicle is stolen and not recovered, the Dealer will provide a \$3,000 Loyalty Credit off the sticker price of a replacement vehicle, when the replacement vehicle is purchased from the Dealer, or, 2) if the Vehicle has sustained damage due to an accident, such that it is determined to be a total loss by the Purchaser's insurance company, the Dealer will provide a \$1,000 Loyalty Credit off the sticker price of a replacement vehicle, when the replacement vehicle is purchased from the Dealer, or, 3) if the Vehicle is in a collision and has suffered damage but has not been determined to be a total loss by the Purchaser's insurance company then the Dealer will provide a \$500.00 Loyalty Credit off the repair of the Vehicle if the repairs are performed by the Dealer.

GUARANTEE PERIOD: Guarantee will commence on the issue date and continue for the term identified in this Guarantee.

Terms of Loyalty Guarantee: The Dealer will guarantee a Loyalty Credit as outlined above only when the replacement vehicle is purchased from the Dealer, or in the case of a collision, repaired by the Dealer. The Purchaser must utilize this credit within 90 days of the Date of theft of the original Vehicle or it will become null and void. This Loyalty Guarantee applies to the original Purchaser only and is not transferable to any future owners.

CONDITIONS: The Dealer will not be obligated to make any payments pursuant to this guarantee unless the purchaser reports the claim to the Dealer and furnishes the following: (1) Confirmation that the theft or collision has been reported to the police by providing date of loss and the police occurrence number (2) Proof that the purchaser's insurance company has made a full and final claim settlement for the total loss of the vehicle under the comprehensive section of the owner's insurance policy (copy of the insurance company's cheque is required, if applicable. In the event primary insurance coverage is not in force, a copy of the police report is required). (3) Proof of ownership (bill of sale & vehicle ownership).

Credit will be issued upon the purchase of another vehicle from the Dealer. The Administrator has no financial obligation or guarantee under this contract. In the event of a theft, please go to www.carnationcanada.com for instructions.
